IF YOU ARE A VICTIM WHO WISHES TO MAKE A FORMAL REQUEST TO DROP CHARGES AND/OR VACATE NO CONTACT ORDER:

- 1. You will need to appear in person at the office of the Warrick County Prosecutor.
- 2. You will need to present a state issued form of identification.
- 3. You will need to meet with a representative of the Warrick County Prosecutor.
- 4. You will need to document your request on an "Affidavit: Request to Vacate No Contact Order and Drop Charge(s)" explaining why you wish the Warrick County Prosecutor to vacate the No Contact Order and decline further prosecution. The Affidavit is attached for your review and use.
- 5. If domestic battery is charged, you will need to complete the CHOICES classes and present the certificate of completion to the Warrick County Prosecutor's Office.
- 6. Your affidavit will then be forwarded to the prosecutor handling your case and will be filed with your case record. The prosecutor will consider your request along with other factors including the severity of the crime, the likelihood the defendant will re-offend, the threat posed to the community by the defendant's actions, and the strength of your case.

THE SUBMISSION OF THE "AFFIDAVIT: REQUEST TO VACATE NO CONTACT ORDER AND DROP CHARGES" DOES NOT REQUIRE THE PROSECUTOR TO HONOR YOUR REQUEST. The decision to prosecute or not rests with the Office of the Warrick County Prosecutor. Your request, while important, is only one of many factors our office considers in proceeding with a criminal prosecution.
